Below is a list of tobacco companies that are either headquartered in the U.S. or conduct significant business here. Publicly-traded companies include the name of the relevant stock exchange and the company's ticker symbol.

In recent years, there has been significant consolidation in the tobacco industry and you will note that a number of these companies are owned by other companies on the list. To help illustrate these relationships, related companies are in a single color, as laid out in the key below.

• Alliance One (NYSE: AOI)

- Global independent leaf tobacco merchant
- Formed through 2005 merger of tobacco processor DIMON and Standard Commercial
- Headquartered in Morrisville, North Carolina
- FY08 Sales: \$2 billion

• Altadis U.S.A.

- Cigar manufacturer
- Key brands: Don Diego, El Producto, H. Upmann, Montecristo
- Subsidiary of Spanish company Altadis, S.A., which was acquired by the UK's Imperial Tobacco in February 2008
- Headquartered in Fort Lauderdale, Florida
- FY07 Sales: \$37 million (est.)

• Altria Group Inc. (NYSE: MO)

- Parent company of Philip Morris, nation's largest tobacco company, and cigar maker John Middleton, Inc.

 UST's shareholders have approved the acquisition and the transaction is expected to close in January 2009
- Headquartered in Richmond, Virginia

Star Scientific Inc. (NASDAQ: STSI)

- Manufacturer of smokeless tobacco products and developer of technology to reduce toxins in tobacco through its wholly-owned subsidiary Star Tobacco Inc.

- Headquartered in Petersburg, Virginia

- **Cigarette Manufacturers Supplies, Inc.** merged into Lane Limited in 2006
- **Cutting Edge Enterprises, Inc.** corporation dissolved due to bankruptcy
- **DIMON Inc.** merged with Standard Commercial Corp. in 2005 to create Alliance Tobacco Corporation

- Liberty Brands LLC filed bankruptcy proceedings in 2007 and discontinued operations
- Medallion Company Inc. merged with Vector in 2002
- **Standard Commercial Corp.** merged with DIMON in 2005 to create Alliance Tobacco Corporation
