Notice Regarding French Financial Transaction Tax (FFTT)

Citibank, N.A. (the Depositary Bank) would like to inform ADR holders that on December 1, 2012, the French Financial Transaction Tax (FFTT) becomes effective on ADRs. French ADR programs that meet specified criteria are subject to FFTT. The Depositary Bank is not responsible for the collection of this tax.

The Depositary Bank will maintain open its DR facilities impacted by the French Transaction Tax (FTT) for all deposits and withdrawals until further notice. Investors should consult with their tax advisors as transactions for issuances, transfers and cancellations may still be liable for the FTT.
